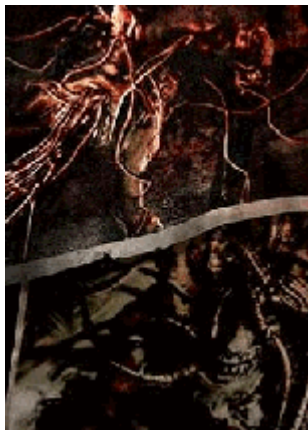

RE5 - SHEVA ALOMAR FILE

At the factory town in Africa which is home to Umbrella’s ‘Plant 57’, Umbrella prepares to use all the personnel who work at the plant, including the parents of Sheva Alomar, as test subjects for Umbrella’s latest B.O.W. and everyone is killed. Umbrella then conceals the entire test by burning the factory down and declaring it a tragic accident.

Now without her parents but refusing to give up hope of their return, Sheva goes to live with her uncle.

*“While only eight years old, Sheva’s peaceful life was brought to an abrupt end by the sound of sirens erupting from the factory. As the sirens pierced the air, an ominous plume of black smoke poured out of the factory.*

*Even as a child, Sheva knew something was terribly wrong. With dread in her heart she ran toward the factory.*

## REUC-UMBRELLA RUSSIAN BRANCH NOTES

Umbrella takes over a chemical processing plant in the Caucasus region of southern Russia. The processing plant is kept as a front, but Umbrella build facilities beneath the surface to perform viral and BOW research. It is Umbrella's newest facility and serves as Sergei Vladimir's base of operations.

*"This branch of Umbrella is a research lab located in the Caucasus region, in the south of Russia. On the surface, it appears to be a government-operated chemical processing plant, but it has been taken over by Umbrella after the fall of the Soviet Union and maintained as a front.*

*Umbrella built facilities beneath the surface to perform viral and B.O.W. research. It is Umbrella's newest base and serves as Sergei Vladimir's headquarters."*

Sheva vows revenge on Umbrella and joins the mercenary team.

*"Her life with her uncle would be brief. Not only was her uncle's family extremely poor, but he also had seven children of his own to care for. Even though Sheva was a blood relative, he probably never would have come for her if he hadn't thought he would receive financial compensation from the factory.*

*That compensation never came. Umbrella never gave out any payments. And soon, her aunt and uncle were unable to feed her. Life was hell for Sheva, not only was she on the verge of starvation, she yearned to be with her parents again. In her grief, she became fixated on the notion that they were still alive.*

*I was one of the doctors involved in the experiments here. The test drugs supplied by Umbrella were routinely administered to patients and results returned to the company. We were trading human lives for money.*

*Their scheme had run off its tracks. They were completely out of control. I've only recently come to know that the data is apparently being used by Umbrella for the development of biological weaponry. We are all criminals here, but the administrator alone had the ultimate motivation in his wife. Her disease had been declared incurable, and the prognosis had driven him to try any and all means to help her.
